

OneCard Photo Consent Form for Minors

Children who are age 16 or younger must present this form in order to have their photo taken for business purposes at a Vancouver Park Board facility. The Parent/Guardian Permission portion on the bottom of the form must be completed and signed. If the photo is being taken for a non-transferrable product (e.g. Flexipass or Leisure Access), the customer's photo is required so the form must be received prior the customer being issued their OneCard. Customer photos are stored in the Vancouver Park Board's database for identity confirmation.

The Vancouver Park Board OneCard gives you consolidated access to recreation programs city-wide. Charges and registration for some programs and services may vary by age and therefore your birth date is collected as part of the registration requirements.

Privacy Policy Statement

Below is the City of Vancouver's Privacy Policy Statement pertaining to the collection of and access to confidential information. The disclosure of sensitive information by the City is governed by the Freedom of Information and Protection of Privacy Act.

1. Our Commitment to Privacy

Your privacy is important to us. To better protect your privacy we are providing you with an explanation of our information acquisition practices and the choices you can make about the way your information is collected and used. By using our services, you agree to be bound by the terms of this Privacy Policy.

2. Personal Information That You Voluntarily Provide to Us

The Vancouver Park Board collects personal information that you voluntarily provide to us in order to complete the requested government transaction and to make your experience more convenient and meaningful. By knowing your preferences, we can deliver relevant transactions and community information to you.

We request the following information in order to complete the requested government transaction: name, address, payment information such as a credit card number and expiration date, billing address and other information required by the government to process the transaction (e.g., Birth Date for age-related programs).

The Vancouver Park Board does not compile, buy, sell, rent or trade mailing lists of our citizens or customers to any organization, partner or other entity. Furthermore, the City of Vancouver does not reveal any e-mail address information to third parties for independent use, unless required to do so by the Freedom of Information and Protection of Privacy Act of British Columbia.

3. Employee Access to Information About You

The Vancouver Park Board will restrict access to your personal information to a limited number of employees based on their need for access to complete their responsibilities. These employees will be trained in the proper handling of customer information. Employees who violate our privacy policy will be subject to our normal disciplinary processes.

4. Sharing Information With Third Parties

The Vancouver Park Board does not sell, barter or disclose information about you to any outside companies. All personal information received from third parties by the Vancouver Park Board, such as credit card payments for services, permits or applications and photographs will be held strictly confidential. Such information will be used only for legitimate internal purposes and will NOT be released to any third parties unless specifically authorized by the individual submitting the information or unless required to do so under the Freedom of Information and Protection of Privacy Act of British Columbia.

5. Our Commitment to Data Security

The Vancouver Park Board employs reasonable and current security electronic and managerial procedures to safeguard the information we collect from you and to prevent the loss, misuse and alteration of such information.
